#### 1. Call to Order

### 3. Ally tutorial/demonstration (Karin Roberts and Bree Callahan, Academic Experience Design & Delivery)

Karin Roberts and Bree Callahan of Academic Experience Design & Delivery provided a presentation (Exhibit 1) and tutorial of Ally which is an accessibility tool, integrated into Canvas.

A member asked what the marketing to students looks like. Roberts responded that an announcement was sent out through Canvas. Additionally, UW IT has an FAQ on their website and they notified instructors. Another member asked if students would be able to use this tool for independent study. Roberts responded that they have reached out to Ally about further developing this function, but there are some technical difficulties. A member asked if Roberts would share with advising. Roberts mentioned that demonstrations are available by invitation.

A member asked if copyright transferred with alternative formats. Roberts and Callahan said that this a question they have discussed in their office. Specifically, they are considering including a disclaimer warning to students about copyright laws, and that by downloading they have agreed to the Terms of Use.

Roberts finally mentioned that any faculty members who would like to volunteer to use Ally in the winter quarter should email Bill Schaefer.

Halverson, the chair, shared a template (Exhibit 2) that the subcommittees might use to focus their meetings and then use to report back to the council. Members offered comments/suggestions. The chair will edit this document and send back out to the council.

# What is Ally?

Software by Blackboard that seamlessly integrates into the UW's Canvas LMS to support improved accessibility of course materials.

### 3 components:

- > Alternative file formats for students (automatically generated)
- > Instructor feedback and guidance
- > Institutional report

Service team for roll-out and support of Ally brings together several organizations:

# **Deployment Timeline**

- Winter 2017: UW-IT piloted Ally with select courses.
- Autumn 2018: Ally's automatically-generated alternative file formats available for students to download in their Canvas courses.
- Winter 2019: Limited release of instructor feedback tool to select instructors.
- Spring 2019: (planned) release of instructor feedback feature to all courses.

### File types supported for conversion

- PDF files
- Microsoft® Word files
- Microsoft® Powerpoint® files
- OpenOffice/LibreOffice files
- Uploaded HTML files

### **Alternative formats provided**

- HTML for viewing content in a web browser, mobile devices, or with a screen reader
- ePub format for reading on iPad and other e-book readers. ePub format allows students to take notes, highlight content, copy, paste, and search text, adjust text and background, and, in some cases, use text-to-speech.
- Electronic braille
- Audio: MP3 versions
