As a service provider to its customers, wingify collects payments through its merchant (Verifone) for the purchased subscription. Hence, even though Wingify does not have the ability to directly impact cardholder data, Wingify's merchant (Verifone) as the processor of such transactions has the ability to impact the security of cardholder data.</p>
