

A NUMERICAL LIAPUNOV-SCHMIDT METHOD WITH APPLICATIONS TO HOPF BIFURCATION ON A SQUARE

ABSTRACT. We discuss an iterative method for calculating the reduced bifurcation equation of the Liapunov-Schmidt method and its numerical approximation. Using appropriate genericity assumptions (with symmetry), we derive a Taylor series for the reduced equation, where the bifurcation behavior is determined by its numerical approximation at a finite order of truncation.

This method is used to calculate reduced equations at Hopf bifurcation of the two-dimensional Brusselator equations on a square with Neumann and Dirichlet boundary conditions. We examine several Hopf bifurcations within the three-parameter space. There are regions where we observe direct bifurcation to branches of periodic solutions with submaximal symmetry.

1. INTRODUCTION

Let $E \hookrightarrow \hat{E}$ be Banach spaces embedded into a Hilbert space with scalar product $\langle \cdot, \cdot \rangle$ and $G : E \times \mathbb{R} \rightarrow \hat{E}$ be a smooth mapping, equivariant under some action of a symmetry group Γ . We consider steady state and Hopf bifurcation of the problem

$$(1) \quad \frac{\partial u}{\partial t} = G(u, \lambda) \text{ with } (u, \lambda) \in E \times \mathbb{R}$$

at a given bifurcation point (u_0, λ_0) . It is well known, in the case of steady state bifurcation with $\text{Ker}(DG(u_0, \lambda_0))$ finite-dimensional, that the Liapunov-Schmidt method can be used to reduce equation (1) to a finite-dimensional bifurcation equation

$$B(\alpha, \lambda) = 0$$

under certain assumptions on $DG(u_0, \lambda_0)$ and its kernel. Usually, these equations are highly nonlinear and an analysis of their solution can be rather difficult. However, in the neighborhood of the bifurcation point we can truncate the Taylor series of the equation at a sufficiently high order to give the bifurcation scenario. In §2 we consider a symmetry-respecting discretization of the

Liapunov-Schmidt method to calculate the approximate bifurcation equation

$$B^h(\alpha, \lambda) = 0,$$

with h the discretization parameter, up to any desired order of truncation of the Taylor series. In particular, we use assumptions of stability and finite determinacy of the exact bifurcation equations (incorporating any symmetries of the problem) to give equivalence of the true and approximate bifurcation scenarios (see also Ashwin, Böhmer, and Mei [9]).

For the rest of this section, we state the necessary definitions and introduce the concepts of germs and singularities of bifurcation equations, their stability and determinacy. We also introduce an iterative Liapunov-Schmidt reduction for Hopf bifurcation (thinking of it as a steady state bifurcation in loop space) and prove a theorem stated in [9] giving convergence of the iterative method. In §2 we discuss and also prove convergence of a suitable discretization of the iterative Liapunov-Schmidt method. This gives an extension of the possible equations to which we can practically apply the Liapunov-Schmidt reduction method. Finally, in §3, we examine applications of the method to computing Hopf bifurcations of the two-dimensional Brusselator equations on a square, with both Neumann and Dirichlet boundary conditions. We show that the bifurcation structure can be determined by a hybrid numerical/analytical/computer-algebraic method in cases where a purely analytical method fails to give results. We verify the calculations for Neumann boundary conditions by comparison with exact results obtained in Ashwin and Mei [10]. The details of the calculations are to be found in the Appendix (in the Supplement section at the end of this issue).

1.1. Preliminaries. The natural language for local steady state bifurcation problems is that of *germs* of functions and their singularities, see, e.g., Martinet [27], Golubitsky et al. [21, 23]. We consider 1-parameter problems in m state variables with a bifurcation at $(0, 0)$. If $E_{m,1}^\nu$ is the module of germs at $(0, 0)$ of C^∞ vector- and matrix-valued functions from $\mathbb{R}^m \times \mathbb{R} \rightarrow \mathbb{R}^\nu$ ($\nu = m, m \times m$, respectively) over the ring $E_{m,1}^1$ of scalar functions, we define the set of bifurcation problems as

$$(2) \quad \mathcal{F} := \{f \in E_{m,1}^m : f(0, 0) = 0, \partial_u f(0, 0) = 0, \partial_\lambda f(0, 0) = 0\}.$$

The set of germs of Γ -equivariant bifurcation equations is defined as

$$\mathcal{F}_\Gamma := \{f \in \mathcal{F} : \gamma f(u, \lambda) = f(\gamma u, \lambda) \forall \gamma \in \Gamma\}.$$

We have implicitly assumed that the symmetry group Γ is represented orthogonally on \mathbb{R}^m . To decide when two bifurcation equations are merely deformations of each other, we need to define an equivalence relation on the space \mathcal{F}_Γ .

Definition 1. Two germs f, g in \mathcal{F}_Γ are *equivalent* (we write $f \sim g$) if and only if there exist germs of functions X, Λ, S such that

$$f(u, \lambda) = S(u, \lambda)g(X(u, \lambda), \Lambda(\lambda)),$$

where

$$\left. \begin{aligned} X(0, 0) = 0, \quad \Lambda(0) = 0, \quad \Lambda'(0) > 0, \\ X(\gamma u, \lambda) = \gamma X(u, \lambda), \quad S(\gamma u, \lambda)\gamma = \gamma S(u, \lambda) \quad \forall \gamma \in \Gamma, \\ \left. \begin{aligned} \partial_u X(0, 0) \\ S(0, 0) \end{aligned} \right\} \text{ are invertible linear maps with positive determinant.} \end{aligned}$$

Obviously, if $(X(u, \lambda), \Lambda(\lambda))$ and its inverse are smooth in some neighborhood of $(0, 0)$, this is the definition of Golubitsky et al. [23]. The definition means that if f and g are equivalent, there is a locally invertible change of parameters $\Lambda(\lambda)$ such that $f(u, \lambda)$ and $g(X(u, \lambda), \Lambda(\lambda))$ have the same “number of zeros”. The germ $g \in \mathcal{F}_T$ is said to be *finitely determined* if $j_k g \sim g$ for some $k \in \mathbb{N}$. (The symbol $j_k g$, called the k -jet, means the truncation of the Taylor expansion of g with respect to all its arguments up to and including homogeneous terms of order k .) We say g is k -determined if $g \sim j_k g$ and $g \not\sim j_l g$ for all $l < k$.

For any $g \in \mathcal{F}_T$ we define the pseudonorm $\|\cdot\|_k^0$ (a norm on the subspace of k -jets) by

$$(3) \quad \|g\|_k^0 = \sum_{|i|+|j|\leq k} \left| \frac{\partial^{|i|+|j|} g}{\partial u^i \partial \lambda^j}(0, 0) \right|,$$

using a multi-index i .

Assumption. For the rest of this paper, we will assume that the germ of the reduced bifurcation equation $g \in \mathcal{F}_T$ is k -determined for some k , and is *stable* with respect to the pseudonorm (3). That is, there exists $\varepsilon > 0$ such that all perturbations $f \in \mathcal{F}_T$ of g with $\|f - g\|_k^0 < \varepsilon$ satisfy $f \sim g$.

In [9], we demonstrate that for a k -determined bifurcation problem, stability with respect to $\|\cdot\|_k^0$ is equivalent to stability with respect to the Sobolev norm $\|\cdot\|_k$. One consequence of this assumption is that Γ must be absolutely irreducibly represented on \mathbb{R}^m (see [23]). This assumption is reasonable from the point of view of *structural stability*, and could also be expressed by saying that g is its own universal unfolding. If a bifurcation comes from a model of a physical problem where we cannot expect to know the equations and parameters exactly, we can only get sensible results if our model is insensitive to small changes in these parameter values. In practice, we cannot tell if a problem is finitely determined and stable unless we can perform Liapunov-Schmidt reduction analytically, in which case we do not need a numerical method! However, we can verify if numerical approximations to coefficients in the Taylor expansion tend to values where the assumption would be broken, e.g., certain coefficients being zero might imply degenerate behavior.

We could also have chosen a weaker equivalence relation. For example, we could permit coordinate changes of the form $\Lambda(x, \lambda)$. This would be quite adequate if we only wish to distinguish branches and not their *direction* of branching in parameter space (this might be sufficient for branch switching of a path-following algorithm). Note that by choosing this more general equivalence, we get lower levels of determinacy; for example the pitchfork $x^3 + x\lambda = 0$ is three-determined for bifurcation equivalence but the truncation at second order $x\lambda = 0$ is two-determined for the weaker equivalence.

1.1.1. *Symmetry.* As demonstrated by Golubitsky et al. [21, 23], we need to include the symmetry of the problem in the reduction in order to obtain an equivariant reduced problem. For finite groups, a symmetry-respecting discretization can be defined as described below. For the case of continuous groups, this is much harder to achieve except in special cases. In general, we need to choose a basis for the discretization that contains its own group orbit, e.g., Fourier series for periodic problems.

If we miss some symmetry in the discretization of a symmetric problem, then naturally we cannot expect to get the actual bifurcation scenario reflected in the approximate one. Instead we should expect to see a deformation of it.

1.1.2. *Consistent differentiability of the discretization.* The above assumptions of stability and finite determinacy require that a few of the low-order terms of the Taylor expansion determine the bifurcation structure. To guarantee that the discretization reflects this behavior, we have to require that the derivatives of the discretized equation up to k th order are $O(h^p)$ close to those of the true equations. This property is called *consistent differentiability* up to order k and is discussed in [9], Böhmer et al. [11–13] and in §2.

As we are concerned with Hopf bifurcation, we first state a standard method (e.g., Vanderbauwhede [36]) for reducing the problem to a steady state problem.

1.1.3. *Hopf bifurcation.* We assume that the linearization $\partial_u G(0, 0)$ of equation (1) has a pair of semisimple imaginary eigenvalues $\pm i\omega_0$, each of multiplicity l , and no other eigenvalues at $m i\omega_0$ for $m \in \mathbb{Z}$, $m \neq \pm 1$, where l is a dimension of an absolutely irreducible representation of Γ . We define the following problem from the original 1-parameter problem:

$$(4) \quad \Phi(u, \tau, \lambda) := G(u, \lambda) - \omega_0(1 + \tau)\partial_s u$$

as a mapping from $C^1_{2\pi} \times \mathbb{R} \times \mathbb{R}$ to $\hat{C}_{2\pi}$ with a trivial solution, where

$$\begin{aligned} \hat{C}_{2\pi} &:= \{u(\cdot) \in C(\mathbb{R}, \hat{E}) : u(s + 2\pi) = u(s)\} \text{ and} \\ C^1_{2\pi} &:= \{u(\cdot), \frac{\partial u}{\partial s}(\cdot) \in C(\mathbb{R}, E) : u(s + 2\pi) = u(s)\}. \end{aligned}$$

We treat the parameter τ as a state variable (i.e., we allow changes of coordinates mixing τ and $u(t)$), but we keep λ as the parameter. We use the usual inner product

$$\langle u(s), v(s) \rangle_{C^i_{2\pi}} := \frac{1}{2\pi} \int_{s=0}^{2\pi} \sum_{j=0}^i \left\langle \frac{\partial^j u}{\partial s^j}, \frac{\partial^j v}{\partial s^j} \right\rangle ds.$$

Using the hypotheses for Hopf bifurcation, we find that $D\Phi(0, 0)$ satisfies the conditions for Liapunov-Schmidt reduction: fixed points in $C^1_{2\pi}$ correspond to periodic solutions of equation (1).

1.2. **The Liapunov-Schmidt reduction.** Consider the operator equation

$$(5) \quad \begin{aligned} \Phi &: E \times \mathbb{R} \rightarrow \hat{E}, \\ 0 &= \Phi(u, \lambda) =: D\Phi(0, 0)(u, \lambda) + R(u, \lambda), \end{aligned}$$

where Φ is a smooth 1-parameter mapping between the Banach spaces $E \hookrightarrow \hat{E}$ with $\Phi(0, 0) = 0$ (in fact we only need one degree of smoothness greater than

the determinacy). Note that by definition, $R(z) = O(\|z\|^2)$, where $z = (u, \lambda)$. We require that

$$\Phi'_0 := D\Phi(0, 0) := (\partial_u \Phi(0, 0), \partial_\lambda \Phi(0, 0))$$

is a Fredholm operator of index 1 with a kernel of dimension $m + 1$, $m \geq 1$. Furthermore, we exclude turning point bifurcations (they are regular points of the mapping Φ) and so can assume, reparameterizing if necessary, that

$$\partial_\lambda \Phi(0, 0) = 0.$$

This corresponds to the assumption of a trivial solution from which the branches bifurcate.

Using the Fredholm condition, we split the spaces in the standard way:

$$\begin{aligned} E \times \mathbb{R} &= \text{Ker}(\Phi'_0) \oplus \text{Im}(\Phi'_0{}^*), \\ \hat{E} &= \text{Ker}(\Phi'_0{}^*) \oplus \text{Im}(\Phi'_0), \end{aligned}$$

with $\Phi'_0{}^*$ the adjoint operator and with \oplus indicating orthogonality with respect to $\langle \cdot, \cdot \rangle$, usually the inner product in $L^2(\cdot)$ of the original Hilbert space into which E and \hat{E} are embedded. We define the projections

$$(6) \quad \begin{aligned} Q : E \times \mathbb{R} &\rightarrow \text{Im}(\Phi'_0{}^*), \quad \text{Ker}(Q) = \text{Ker}(\Phi'_0) = \text{Ker}(\partial_u \Phi_0) \times \mathbb{R} \quad \text{and} \\ \hat{Q} : \hat{E} &\rightarrow \text{Im}(\Phi'_0), \quad \text{Ker}(\hat{Q}) = \text{Ker}(\Phi'_0{}^*). \end{aligned}$$

Using these projectors, we write $z = \eta + w$ with $\eta \in \text{Ker}(\Phi'_0)$ and $w \in \text{Im}(\Phi'_0{}^*)$ and split equation (5) into two:

$$(7) \quad \hat{Q}\Phi(\eta + w) = 0,$$

$$(8) \quad (I - \hat{Q})\Phi(\eta + w) = 0.$$

Equation (7) is solvable in terms of η for small η and gives $w(\eta) = O(\eta^2)$ uniquely, and this is substituted into equation (8) to give the *reduced bifurcation equation*:

$$(9) \quad B(\eta) := (I - \hat{Q})\Phi(\eta + w(\eta)) = (I - \hat{Q})R(\eta + w(\eta)) = 0.$$

In order for symmetries of Φ to be inherited by B , we must choose projectors Q , \hat{Q} commuting with the symmetries, see e.g., [21] or [36]. We now give an iterative method to solve equation (7) that develops the Taylor expansion of B and is presented in [6–9]. This was used in [1] to calculate higher-order terms in a periodic boundary value problem. The functions $w(\eta)$ and $B(\eta)$ can be obtained iteratively using the following Algorithm.

Algorithm 2. Truncated Liapunov-Schmidt Method.

Initialization. Pick an initial function

$$(10) \quad w_1(\eta) = 0,$$

a mapping from $\text{Ker}(\Phi'_0)$ to $\text{Im}(\Phi'_0{}^*)$. We identify $\eta \in \text{Ker}(\Phi'_0)$ with $(\alpha, \lambda) \in \mathbb{R}^{m+1}$ and $\text{Ker}(\Phi'_0{}^*)$ with \mathbb{R}^m .

Iteration. For $k = 2, 3, \dots$ until determinacy, do: at each stage define the truncated bifurcation equations to be

$$(11) \quad B_k(\eta) := (I - \hat{Q})j_k R(\eta + w_{k-1}(\eta)) = 0,$$

where B_k is a polynomial of k th order from $\text{Ker}(\Phi'_0)$ to $\text{Ker}(\Phi_0^*)$, and

$$(12) \quad w_k(\eta) := -Q(\Phi'_0)^{-1}\hat{Q}j_k R(\eta + w_{k-1}(\eta)).$$

This iteration creates a sequence of k th-order polynomial functions

$$(13) \quad w_k : \text{Ker}(\Phi'_0) \rightarrow \text{Im}(\Phi_0^*).$$

Theorem 3. For the iteration defined in (11), (12), we have

$$w_k(\eta) = j_k w(\eta) \quad \text{and} \quad B_k(\eta) = j_k B(\eta).$$

Proof. Consider

$$(14) \quad w_{k+1} - w_k = -Q(\Phi'_0)^{-1}\hat{Q} [j_{k+1}R(\eta + w_k(\eta)) - j_k R(\eta + w_{k-1}(\eta))].$$

Now $j_1(R(\eta)) = 0$ implies that

$$j_k(R(y(\eta))) = j_k(R(j_{k-1}y(\eta)))$$

for all functions $y(\eta)$ with $j_0(y(\eta)) = 1$. By induction we get that for all $k \geq 2$

$$\begin{aligned} & j_k(R(\eta + w_k(\eta)) - R(\eta + w_{k-1}(\eta))) = 0 \\ \Rightarrow & j_k(w_{k+1} - w_k) = 0 \\ \Rightarrow & j_k w_{k+1} = w_k. \end{aligned}$$

By the fact that $j_k Q\Phi(\eta + w_k(\eta)) = j_k Q\Phi(\eta + w(\eta)) = 0$, this means that the solution $w(\eta)$ of $QR(\eta + w(\eta)) = 0$ has Taylor series $j_k w(\eta) = w_k(\eta)$. This implies that $j_k B(\eta) = B_k(\eta)$. \square

2. DISCRETIZING THE TRUNCATED LIAPUNOV-SCHMIDT METHOD

2.1. Finite and continuous symmetries. As described in Golubitsky and Stewart [22], at Hopf bifurcation we gain an extra S^1 symmetry from the fact that our system is autonomous, and this may cause problems with the discretization. However, the simplicity of the dependence on the time derivative allows us to work in spaces of finite Fourier sums:

$$P_k := \left\{ \sum_{m=0}^k a_m \cos mt + b_m \sin mt : a_m, b_m \in E \right\}.$$

In fact, the calculation of w_{k+1} and B_{k+1} can be performed in P_{2k} .

For other continuous symmetries, we can think of the whole group as split into the semidirect product of a continuous and a finite group $\Gamma = \Gamma_c \times_s \Gamma_f$. For many important problems, the continuous group can be represented as acting on a Γ -symmetry-respecting basis (e.g., Fourier series for T^k , spherical harmonics for $SO(3)$, see e.g. Dellnitz [16] and Gekeler [19]). In the case that finite products of elements in this basis can be expressed or approximated as finite sums of other elements in the basis, we can use finite bases to describe a discretization preserving the full symmetry. We therefore assume for the rest of

this section that our problem is equivariant under some finite symmetry group Γ .

In order to preserve equivariance in the discretized iteration process, we use the technique developed in Böhmer [11, 12]. We now give a short outline of necessary results adapted from [12].

2.2. Consistently differentiable discretization methods. We consider discretizations of (5) indexed by $h \in H$. We use linear bounded restriction operators π^h and $\hat{\pi}^h$ mapping $E \times \mathbb{R}$ and \hat{E} into the respective finite-dimensional discrete spaces $E^h \times \mathbb{R}$ and \hat{E}^h . We assume π^h acts on $z = (u, \lambda) \in E \times \mathbb{R}$ by transforming $u \in E$ into a discrete $u^h = \pi^h u \in E^h$, leaving λ unchanged. Let $\pi^h, \hat{\pi}^h$ satisfy:

$$(15) \quad \begin{aligned} \pi^h : E \times \mathbb{R} &\rightarrow E^h \times \mathbb{R}, & \hat{\pi}^h : \hat{E} &\rightarrow \hat{E}^h, \\ \pi^h z = \pi^h(u, \lambda) &= (\pi^h u, \lambda) \text{ and } \|\pi^h z\| = \|z\| + O(h^p \|z\|_{E_s}), \\ \|\hat{\pi}^h \hat{y}\| &= \|\hat{y}\| + O(h^p \|\hat{y}\|_{\hat{E}_s}) \end{aligned}$$

for fixed z, \hat{y} in appropriate subspaces E_s, \hat{E}_s . The $O(h^p)$ term in $\pi^h z$ is due to $\pi^h u$. The operator Φ in (5) is transformed into a discrete operator $\Phi^h : \text{domain}(\Phi^h) \subset E^h \rightarrow \hat{E}^h$. If E is defined for a Sobolev norm with derivatives of order $|i| + j \leq n$, then E_s requires a norm with derivatives of orders $|i| + j \leq n + p$. In such a case we choose n such that Φ is continuous on E . For simplicity, we do not distinguish between E, \hat{E} and their smooth subspaces E_s, \hat{E}_s . Strictly speaking, the latter are needed for consistency and convergence in (15) and (16), but these conditions may be relaxed by using weak discrete Sobolev norms as indicated in Hackbusch [26]. By expanding Φ in a Taylor series, we can ensure that, for many discretization methods, Φ^h is r times consistently differentiable:

$$(16) \quad \begin{cases} \Phi^h(\pi^h z) = \hat{\pi}^h \Phi z + O(h^p \|z\|_{E_s}) \text{ for } z \in E_s \text{ and for } j = 1, \dots, r, \\ \Phi^{h(j)}(\pi^h z) \pi^h z_1 \dots \pi^h z_j = \hat{\pi}^h [\Phi^j(z) + \varepsilon(h^p, z)] z_1 \dots z_j \\ \text{for } z, z_1, \dots, z_j \in E_s, \end{cases}$$

where $\varepsilon(h^p, z)$ represents a j -linear operator and

$$\|\varepsilon(h^p, z)\| \leq O(h^p \|z\|_{E_s}).$$

Since the operators $\Phi^{h(j)}(\pi^h z) \pi^h \dots \pi^h$ and $\hat{\pi}^h \Phi^{(j)}(z)$ in (16) act multilinearly on z_1, \dots, z_j , the same is true for $\varepsilon(h, z)$ by definition. Example calculations showing this are described in [9]. A combination of (16) with the usual stability

$$\|z^h - \bar{z}^h\| \leq C \|\Phi^h(z^h) - \Phi^h(\bar{z}^h)\|$$

for z^h, \bar{z}^h near the solution, yields the intended convergence.

2.3. Equivariant discretization methods. We choose discretization methods which preserve the Γ -equivariance of the original problem. In §1 we discussed the matter of reducing the problem to a finite-dimensional system with discrete symmetries and finite group Γ . Indicating the action of $\gamma \in \Gamma$ on elements in

E , \hat{E} , E^h and \hat{E}^h , respectively, with the same γ , we have

$$(17) \quad \Phi(\gamma u, \lambda) = \gamma \Phi(u, \lambda) \quad \text{for all } \gamma \in \Gamma.$$

For the discretization Φ^h we have to choose E^h and \hat{E}^h such that, e.g., $u^h \in E^h$ implies that $\gamma u^h \in E^h$ for all $\gamma \in \Gamma$. Furthermore, Φ^h and the restriction operators π^h , $\hat{\pi}^h$ must be defined such that they commute with the action of Γ on the appropriate spaces, i.e.,

$$(18) \quad \begin{aligned} \Phi^h(\gamma u^h, \lambda) &= \gamma \Phi^h(u^h, \lambda), \\ \pi^h \gamma u^h &= \gamma \pi^h u^h, \quad \hat{\pi}^h \gamma \hat{u}^h = \gamma \hat{\pi}^h \hat{u}^h \\ &\text{for all } \gamma \in \Gamma \text{ and } u^h \in E^h, \hat{u}^h \in \hat{E}^h. \end{aligned}$$

This is achieved by approximating the Γ -equivariant terms of, e.g., function values, derivatives or integrals in an appropriate Γ -equivariant way. As examples, let us study the evaluation of u , the Laplacian Δu and a function $g(\nabla u)$ for functions defined on a domain $\Omega \subset \mathbb{R}^2$ admitting a symmetry group Γ . The set of gridpoints \mathbf{G}_h , constituting E^h (and \hat{E}^h), and the approximations Δ^h , ∇^h and u^h for Δ , ∇ and u respectively, satisfy

$$\begin{aligned} \gamma \mathbf{G}_h &= \mathbf{G}_h, \quad \Delta^h \gamma u^h = \gamma \Delta^h u^h, \\ \nabla^h \gamma u^h &= \gamma \nabla^h u^h, \quad u^h(\gamma(x, y)) = \gamma u^h(x, y) \quad \forall \gamma \in \Gamma. \end{aligned}$$

Hence, we can use the five-point star approximation for finite difference approximation of the Laplacian Δ on $\Omega = [0, 1]^2$ ($\Gamma = \mathbf{D}_4$), or the seven-point star for a regular hexagonal grid ($\Gamma = \mathbf{D}_6$). For $g(\nabla^h u)$ or u^h we must do approximations using these Γ -invariant stars. In this case we have convergence of order $p = 2$. The discrete inner products, e.g. (22), have to be approximated with the same order, so for $\Omega = [0, 1]^2$ a trapezoidal rule with appropriate weights on the boundary points will work.

In the case of finite elements, the finite-dimensional subspaces should be chosen equivariantly. If variational approaches to (17) are studied, the Γ -equivariance is directly inherited by the discretizations. If finitely many functionals are equal to zero, the corresponding discretizations must again be Γ -equivariant.

By these considerations we indicate how (17) can be equivariantly discretized. Detailed examples are studied in Allgower et al. [4, 5].

Since solutions of arbitrarily discretized $\Phi^h(u^h) = 0$ will not respect any symmetries of the problem, we have to formulate Φ^h with respect to a basis maintaining the symmetry, a so-called *symmetry-respecting basis*; see Stiefel-Fässler [31], Allgower, Böhmer, and Mei [4, 5], Allgower, Böhmer, Georg, and Miranda [3], Georg and Miranda [20] and Douglas and Mandel [17]. Then we are able to numerically define fixed point subspaces within E^h and \hat{E}^h :

$$(19) \quad E^{h, \Sigma} := \text{Fix}^\Sigma(E^h) := \{z^h \in E^h \mid z^h = \sigma z^h \quad \forall \sigma \in \Sigma\}.$$

As a consequence of (18) we are able to consider the discrete problem $\Phi^h(z^h)$ on a fixed point subspace (19) of subgroups $\Sigma \preceq \Gamma$, i.e., we have that Φ^h and all its derivatives (and remainder terms) evaluated at z^h are Σ_{z^h} equivariant, with Σ_{z^h} being the isotropy subgroup of the point z^h . If Φ^h is stable or r times consistently differentiable, the same is true for $\Phi^{h, \Sigma}$.

Throughout, we have assumed that we study the original problem in its singularity at $(0,0)$. The discretization Φ^h will usually not be singular at $(0, 0)$, but at a slightly perturbed point, in particular, the bifurcation will occur at some $\lambda^h \approx 0$. Again, we use coordinate transformations to shift the singularity of Φ^h to $(0, 0)$. Let z, φ or $\hat{\psi}$ be solutions of

$$\Phi(z) = 0, \quad \Phi'(0, 0)\varphi = g \text{ or } \Phi'^*(0, 0)\hat{\psi} = \hat{g};$$

then there exist discrete solutions $z^h, \varphi^h, \hat{\psi}^h$ of

$$\Phi^h(z^h) = 0, \quad \Phi^{h'}(0, 0)\varphi^h = \pi^h g \text{ or } \Phi^{h'*}(0, 0)\hat{\psi}^h = \hat{\pi}^h \hat{g},$$

see Allgower and Böhmer [2], such that

$$\pi^h z - z^h = O(h^p), \quad \pi^h \varphi - \varphi^h = O(h^p), \quad \hat{\pi}^h \hat{\psi} - \hat{\psi}^h = O(h^p).$$

The $O(h^p)$ terms are also elements in $E^{h,\Sigma}$. For more details, see [9].

2.4. Equivariant discretization near singularities. We shall restrict our discussion to discretizations of bifurcation problems at $(0, 0)$ with the following properties:

- (a) $\partial_\lambda \Phi(0, 0) = 0$;
- (b) The discretized problem has the identical symmetry and a bifurcation at $(0, 0)$, usually after a shift;
- (c) $\partial_\lambda \Phi^h(0, 0) = 0$;
- (d) The kernels of Φ'_0 and $\Phi^{h'}_0$ have the same dimension.

(Since the higher dimensions of these kernels are generically caused by symmetry, this and our assumption in §1 imply 20(d).) We need the results in §§2.1 and 2.2 to be able to formulate an appropriate discretization reflecting the bifurcation scenario close to singularities. This singularity may be analytically or numerically determined in the sense that we know either

$$\text{Ker}(\Phi'_0) = [\psi_1, \dots, \psi_m] \times \mathbb{R}, \quad \text{Ker}(\Phi'^*_0) = [\hat{\psi}_1, \dots, \hat{\psi}_m]$$

or approximations

$$(21) \quad \text{Ker}(\Phi^{h'}_0) = [\psi^h_1, \dots, \psi^h_m] \times \mathbb{R}, \quad \text{Ker}(\Phi^{h'*}_0) = [\hat{\psi}^h_1, \dots, \hat{\psi}^h_m]$$

with

$$\psi^h_i = \pi^h \psi_i + O(h^p), \quad \hat{\psi}^h_i = \hat{\pi}^h \hat{\psi}_i + O(h^p).$$

Working with an equivariant discretization method, we may assume that ψ^h_i and $\hat{\psi}^h_i$ have been determined in the same fixed point subspaces as the ψ_i and $\hat{\psi}_i$ respectively. Furthermore, our assumption that the problem is a generic Γ -equivariant problem means that the kernel of the linearized operator is of a generic size, i.e., the dimension of an absolutely irreducible representation of Γ for the case of one parameter.

In §1 we described a *truncated Liapunov-Schmidt method*, defining the B_k and w_k . By means of the properties of the operator Φ , the projections Q and \hat{Q} have to be transformed into a discrete setting. We now discuss these discrete projectors Q^h and \hat{Q}^h .

A discrete realization of Algorithm 2 is prevented by the fact that the usual stability of Φ^h , and hence convergence, breaks down near singularities. This difficulty is studied in Böhmer [11, 12] and Böhmer and Mei [13]. However, the situation here is much simpler, owing to the assumption of genericity in the (symmetric) discrete setting. In [11] and [13], we had to use extension operators for the case of $\text{Ker}(\Phi'_0)$ being of a different dimension than $\text{Ker}(\Phi_0^h)$. We use the discrete pairing or inner product $\langle \cdot, \cdot \rangle^h$ related to $\langle \cdot, \cdot \rangle$ by

$$(22) \quad \langle \pi^h u, \pi^h v \rangle^h = \langle u, v \rangle + O(h^p \|u\|_s \|v\|_s),$$

where $\|\cdot\|_s$ indicates the smooth norm. Corresponding results hold in \hat{E} and \hat{E}^h as well. We assume that the original and discrete pairings $\langle \cdot, \cdot \rangle$ and $\langle \cdot, \cdot \rangle^h$ are Γ -invariant,

$$(23) \quad \langle u, v \rangle = \langle \gamma u, \gamma v \rangle, \quad \langle u^h, v^h \rangle^h = \langle \gamma u^h, \gamma v^h \rangle^h \quad \forall \gamma \in \Gamma,$$

by defining, if necessary, a symmetrized version

$$[u, v] := \frac{1}{|\Gamma|} \sum_{\gamma \in \Gamma} \langle \gamma u, \gamma v \rangle$$

for the finite group Γ , where $|\Gamma|$ is the order of Γ . We define

$$(24) \quad \begin{aligned} E^h &= \text{Ker}(\Phi_0^h) \oplus \text{Im}(\Phi_0^{h'*}) =: N^h \oplus M^h, \\ \hat{E}^h &= \text{Ker}(\Phi_0^{h'*}) \oplus \text{Im}(\Phi_0^h) =: \hat{N}^h \oplus \hat{M}^h. \end{aligned}$$

Since all the kernels and images in (24) are Γ -invariant subspaces, the orthogonality is also valid for the Γ -invariant pairing $\langle \cdot, \cdot \rangle^h$. The next proposition relates the continuous and discrete projectors, and is stated without proof in [9]. Consider

$$\begin{aligned} Qu &:= u - \sum_{i=1}^m \langle \psi_i, u \rangle \psi_i, \\ Q(u, \lambda) &:= Qu \text{ for } (u, \lambda) \in E \times \mathbb{R}, \\ \hat{Q}\hat{u} &:= \hat{u} - \sum_{i=1}^m \langle \hat{\psi}_i, \hat{u} \rangle \hat{\psi}_i \text{ for } \hat{u} \in \hat{E}, \\ Q^h u^h &:= u^h - \sum_{i=1}^m \langle \psi_i^h, u^h \rangle^h \psi_i^h, \\ Q^h(u^h, \lambda) &:= Q^h u^h \text{ for } (u^h, \lambda) \in E^h \times \mathbb{R}, \\ \hat{Q}^h \hat{u}^h &:= \hat{u}^h - \sum_{i=1}^m \langle \hat{\psi}_i^h, \hat{u}^h \rangle^h \hat{\psi}_i^h \text{ for all } \hat{u}^h \in \hat{E}^h. \end{aligned}$$

Proposition 4. *Under the assumption that (21)–(23) are satisfied, the projectors $Q, \hat{Q}, Q^h, \hat{Q}^h$ are Γ -equivariant projections satisfying*

$$\begin{aligned} \pi^h Qz - Q^h \pi^h z &= O(h^p \|z\|), \\ \hat{\pi}^h \hat{Q}\hat{z} - \hat{Q}^h \hat{\pi}^h \hat{z} &= O(h^p \|\hat{z}\|), \end{aligned}$$

with the error terms also equivariant under Γ . The same is true for the projection $I - Q$.

Proof. Since, for each $\gamma \in \Gamma$, the $\{\gamma \psi_i\}_{i=1}^m$ represent a basis for $\text{Ker}(\partial_u \Phi_0)$, we have

$$Q\gamma u = \gamma u - \sum_{i=1}^m \langle \psi_i, \gamma u \rangle \psi_i = \gamma u - \sum_{i=1}^m \langle \gamma \psi_i, \gamma u \rangle \gamma \psi_i = \gamma Qu$$

and so on. Furthermore,

$$\begin{aligned} \pi^h Q u - Q^h \pi^h u &= \sum_{i=1}^m \left(\left(\langle \psi_i, u \rangle - \langle \psi_i^h, \pi^h u \rangle^h \right) \pi^h \psi_i \right. \\ &\quad \left. + \langle \psi_i^h, \pi^h u \rangle^h (\pi^h \psi_i - \psi_i^h) \right) = O(h^p). \quad \square \end{aligned}$$

Summarizing, we have discrete operators that are close to Φ , Q and \hat{Q} up to Γ -equivariant perturbations of (relative) size $O(h^p)$.

To obtain stability of the numerical solutions near the singularity in (11), (12), it is necessary to modify the conventional stability by assuming that

$$(25) \quad \Phi_0^{h'}|_{M^h} : M^h \rightarrow \hat{M}^h := \Phi_0^{h'}(M^h)$$

is boundedly invertible, uniformly for small h , in the appropriate norms. Results of this type have been obtained for discretized problems by Brezzi, Rappaz, and Raviart [14], Esser [18], Grigorieff [25], Reinhard [30], Stummel [32, 33], and Vainikko [35]. To get the k -jets, j_k , for the discrete problem, we merely truncate the Taylor series for the discrete operators. The numerical version of the iterative Liapunov-Schmidt algorithm follows.

Algorithm 5. Discrete Truncated Liapunov-Schmidt Method.

Initialization. Define the function $w_1^h : \text{Ker}(\Phi_0^{h'}) \rightarrow \text{Im}(\Phi_0^{h'*})$ by

$$w_1(\eta^h) = 0,$$

for all $\eta^h \in \text{Ker}(\Phi_0^{h'})$.

Iteration. For $k = 2, 3, \dots$ until determinacy, do:

$$(26) \quad B_k^h(\eta^h) := (I - \hat{Q}^h) j_k R^h(\eta^h + w_{k-1}^h(\eta^h)),$$

where B_k^h is a polynomial of k th order in η^h from $\text{Ker}(\Phi_0^{h'})$ to $\text{Ker}(\Phi_0^{h'*})$. We generate the next function w_k^h with the formula

$$(27) \quad w_k^h(\eta^h) := -Q^h(\Phi_0^{h'})^{-1} \hat{Q}^h j_k R^h(\eta^h + w_{k-1}^h(\eta^h)),$$

where w_k^h is a k th-order polynomial from $\text{Ker}(\Phi_0^{h'})$ to $\text{Im}(\Phi_0^{h'*})$.

The following result shows the required convergence of the discrete approximations to the true bifurcation equation. Thus, we are assured by the stability and k -determinacy of B that (for small enough h) $B = 0$ and $B_{k+1}^h = 0$ give the same bifurcation scenario.

Theorem 6. *Let Φ and its discretization Φ^h satisfy the following conditions:*

- (i) r times consistent differentiability, see (16),
- (ii) Φ^h is a Γ -equivariant discretization for Φ , see (18);
- (iii) the singularity satisfies (20) and (21);
- (iv) the pairings are chosen to satisfy (22) and (23);
- (v) $\Phi_0^{h'}$ satisfies the modified stability, see (25).

Then the w_k, B_k from Algorithm 2 and their discrete approximations from Algorithm 5 satisfy

$$(28) \quad \|w_k^h(\pi^h \eta) - \pi^h w_k(\eta)\| = O(h^p \|\eta\|), \quad \|B_k^h(\pi^h \eta) - B_k(\eta)\| = O(h^p \|\eta\|)$$

with the differences being Γ -equivariant. The norm for the w_k^h approximation is given by (23); for B_k^h we use (3). Furthermore, B_k and B_k^h are elements of \mathcal{F}_Γ .

Proof. We proceed by induction. Obviously, we have that, with the multi-index ν ,

$$(29) \quad j_{k+1} R^h (\eta^h + w_k^h(\eta^h)) = j_{k+1} \left(\sum_{|\nu|=2}^{k+1} \frac{1}{\nu!} \Phi_0^{h(\nu)} (\eta^h + w_k^h(\eta^h))^\nu \right).$$

In (29) and below in (30), (31), we may also omit all the discretization parameters h to obtain the corresponding formulas for the original problem. To obtain (28), we have to compute the derivatives in (3) for $B_{k+1}(\eta)$ and $B_{k+1}^h(\pi^h \eta)$ as polynomials in η of order $k + 1$ with respect to η . Therefore, only derivatives up to order $k + 1$ are of interest. Since the defining terms for B_{k+1} and B_{k+1}^h , except $\eta, w_k(\eta)$ and $\eta^h, w_k^h(\eta^h)$, are independent of η and η^h , respectively, see (6), (9), (11), (26), (27), (29), we exchange the derivatives $\frac{\partial^i}{\partial \eta^i}$, $\frac{\partial^i}{\partial (\eta^h)^i}$ of the relevant operators and need only study, for the multi-indices i and j ,

$$(30) \quad \frac{\partial^i}{(\partial \eta^h)^i} (\eta^h + w_k^h(\eta^h))^j, \quad 0 \leq |i|, |j| \leq k + 1,$$

where we identify $\eta \in \text{Ker}(\Phi_0')$ and $\eta^h \in \text{Ker}(\Phi_0^{h'})$ with elements in \mathbb{R}^{m+1} .

For any $i = (i_1, \dots, i_{m+1})$, $j = (j_1, \dots, j_{m+1})$ and $|i|, |j| \leq k + 1$, we obtain

$$(31) \quad \frac{\partial^i}{\partial \eta^i} (\eta)^j = \begin{cases} 0 & \text{if } i_l > j_l \text{ for at least one } l, \\ j! & \text{if } i = j, \\ \frac{j!}{(j-i)!} \eta^{j-i} & \text{if } i_l \leq j_l \text{ for all } l. \end{cases}$$

In particular, we find with $\pi^h w_1 = w_1^h = 0$ and $\eta^h = \eta$, using (16) and Proposition 4, that

$$(32) \quad \begin{aligned} & \frac{\partial^i}{\partial \eta^i} (B_2^h(\pi^h \eta) - B_2(\eta)) \\ &= (I - \hat{Q}^h) \frac{1}{2} \Phi_0^{h(2)} \pi^h \frac{\partial^i}{\partial \eta^i} (\eta)^2 - (I - \hat{Q}) \frac{1}{2} \Phi_0^{(2)} \frac{\partial^i}{\partial \eta^i} (\eta)^2 \\ &= (I - \hat{Q}^h) \frac{1}{2} (\Phi_0^{h(2)} \pi^h - \hat{\pi}^h \Phi_0^{(2)}) \frac{\partial^i}{\partial \eta^i} (\eta)^2 \\ & \quad + [(I - \hat{Q}^h) \hat{\pi}^h - (I - \hat{Q})] \frac{1}{2} \Phi_0^{(2)} \frac{\partial^i}{\partial \eta^i} (\eta)^2 \\ &= O(h^p \|\eta\|). \end{aligned}$$

Similarly, by (12), (27), (16), and Proposition 4,

$$\begin{aligned}
 (33) \quad & \frac{\partial^i}{(\partial \eta^h)^i} (w_2^h(\pi^h \eta) - w_2(\eta)) \\
 &= Q^h(\Phi_0^{h'})^{-1} \hat{Q}^h j_2 \frac{1}{2} (\Phi_0^{h(2)} \pi^h - \hat{\pi}^h \Phi_0^{(2)}) \frac{\partial^i}{\partial \eta^i} (\eta)^2 \\
 &\quad + [Q^h(\Phi_0^{h'})^{-1} \hat{Q}^h j_2 \hat{\pi}^h - Q(\Phi_0')^{-1} \hat{Q} j_2] \frac{1}{2} \Phi_0^{(2)} \frac{\partial^i}{\partial \eta^i} (\eta)^2 \\
 &= O(h^p \|\eta\|),
 \end{aligned}$$

where in both cases the $O(h^p \|\eta\|)$ terms are Γ -equivariant.

An inductive combination of (26), (27), (29)–(33) finally gives that B_{k+1}^h is a small Γ -equivariant perturbation of B_{k+1} in the pseudonorm (3). The corresponding estimates for derivatives of $w_{k+1}^h(\pi^h \eta) - w_{k+1}(\eta)$ with respect to η are valid as well, but are not really important.

B_{k+1} and B_{k+1}^h are both Γ -equivariant since they are defined by Γ -equivariant operations based on the appropriate identification of $\eta = (\alpha, \lambda) \in \mathbb{R}^{m+1}$. Hence, we only have to show that for B_{k+1} and B_{k+1}^h we have, for example,

$$B_{k+1}(0, 0) = 0, \quad \partial_\alpha B_{k+1}(0, 0) = 0, \quad \partial_\lambda B_{k+1}(0, 0) = 0.$$

For B_{k+1} and B_{k+1}^h , this is an immediate consequence of the fact that their linear terms are annihilated by the projection $(I - \hat{Q})j_{k+1}$. \square

3. HOPF BIFURCATION FOR THE 2-D BRUSSELTOR EQUATIONS

In this section we consider an example application of the numerical Liapunov-Schmidt technique to a Hopf bifurcation problem of a partial differential equation on a square domain. We consider an example from the dynamics of chemical systems. After discussing the linear problem and the symmetries of the nonlinear problem, we use null space coordinates in \mathbb{C}^2 giving two coupled cubic equations which generically determine the branching behavior. This normal form is investigated using results of Swift [34], and we obtain the bifurcation behavior at a variety of different spatial mode numbers, with both Neumann and Dirichlet boundary conditions.

3.1. The Brusselator equations. The following reaction-diffusion system proposed by Prigogine and Glansdorff [29] is a model for the Belousov-Zhabotinskii reaction; although it is not a very good model, it is simple enough to be amenable to analysis while showing a wide range of dynamical and bifurcation behavior:

$$\begin{aligned}
 (34) \quad \partial_t u_1 &= \Delta u_1 + A - (B + \lambda + 1)u_1 + u_1^2 u_2 \text{ in } \Omega := [0, \pi] \times [0, \pi], \\
 \partial_t u_2 &= d\Delta u_2 + (B + \lambda)u_1 - u_1^2 u_2,
 \end{aligned}$$

where $A, d \in (0, +\infty)$, $B \in [0, \infty)$ are parameters. For convenience, we consider an extra parameter $\lambda \in \mathbb{R}$ as a bifurcation parameter. We take the boundary conditions to be Neumann ($\partial_n u_1 = \partial_n u_2 = 0$) or Dirichlet ($u_1 = A, u_2 = (B + \lambda)/A$) on $\partial\Omega$, where ∂_n represents the normal derivative along

the boundary of Ω . It is easy to verify that this problem has a trivial solution

$$(35) \quad (u_1, u_2) = (A, (B + \lambda)/A).$$

For simplicity, we fix the parameters A , B and d and consider bifurcation of equation (34) along the trivial solution curve with respect to λ . To this end, we substitute

$$(u_1, u_2) \leftarrow (A, (B + \lambda)/A) + (u_1, u_2), \quad t \leftarrow (\omega_0 + \tau)t$$

(the frequency ω_0 is to be specified later) and derive the following equation from equation (34):

$$(36) \quad \Phi(u, \lambda, \tau) := [L(B)u - \omega_0 \partial_t u] + R(u, \lambda, \tau),$$

where $u := (u_1, u_2)^T$,

$$(37) \quad L(B) := \begin{pmatrix} \Delta + B - 1 & A^2 \\ -B & d\Delta - A^2 \end{pmatrix},$$

and

$$(38) \quad R(u, \lambda, \tau) := \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left(\frac{B + \lambda}{A} u_1^2 + 2A u_1 u_2 + u_1^2 u_2 + \lambda u_1 \right) - \tau \partial_t u.$$

The operator L maps from $E := (C_0^{2,s}(\Omega))^2$ to $\hat{E} := (C(\Omega))^2$, where $C_0^{2,s}(\Omega)$ consists of twice differentiable functions on Ω satisfying a Hölder condition and homogeneous Dirichlet or Neumann boundary conditions. In particular, we consider bases for $C_{2\pi}^1, \hat{C}_{2\pi}$, see §1.1.3, with coefficients in E, \hat{E} , respectively, to be

$$\{1, \cos lt, \sin lt : l = 1, 2, \dots\}.$$

Obviously, the operator Φ maps $C_{2\pi}^1$ into $\hat{C}_{2\pi}$ and

$$\Phi(0, \lambda, \tau) = 0 \quad \text{for all } \lambda, \tau \in [0, \infty).$$

Considering eigenfunctions of the Laplacian $-\Delta$ on the unit square with Neumann or Dirichlet boundary conditions, one sees easily that if for a given constant $d_0 > 0$ the system

$$(39) \quad B - 1 - A^2 - (1 + d_0)c = 0,$$

$$(40) \quad (1 + c)(A^2 + d_0c) - d_0Bc > 0$$

has solutions $(A_0, B_0) \in \mathbb{R}_+^2$ for exactly one eigenvalue $c := (k^2 + l^2)\pi^2$, $k, l \in \mathbb{N}$ of $-\Delta$, then the operator

$$(41) \quad \partial_u \Phi_0 := \partial_u \Phi(0, 0, 0) = L(B_0) - \omega_0 \partial_t$$

with $\omega_0 := \sqrt{(1 + c)(A_0^2 + d_0c) - d_0B_0c}$ is singular. We assume that the eigenvalue c has multiplicity 2, and so the null space $\text{Ker}(\partial_u \Phi_0)$ is 4-dimensional.

Moreover, we can write

$$(42) \quad \text{Ker}(\partial_u \Phi_0) = [\psi_1, \psi_2, \psi_3, \psi_4]$$

with

$$P = (P_{ij})_{i,j=1,2} := \frac{1}{\omega_0} \begin{pmatrix} B_0 - 1 - c & A_0^2 \\ -B_0 & -d_0 c - A_0^2 \end{pmatrix},$$

$$\psi_1 := (e_1 \cos t + P e_1 \sin t) \phi_{kl}, \quad \psi_2 := (-P e_1 \cos t + e_1 \sin t) \phi_{kl},$$

$$\psi_3 := (e_1 \cos t + P e_1 \sin t) \phi_{lk}, \quad \psi_4 := (-P e_1 \cos t + e_1 \sin t) \phi_{lk},$$

where

$$e_1 := \begin{pmatrix} 1 \\ 0 \end{pmatrix}, \quad e_2 := \begin{pmatrix} 0 \\ 1 \end{pmatrix}$$

and for Dirichlet boundary conditions

$$\phi_{kl}(x, y) := \sin kx \sin ly, \quad \phi_{lk}(x, y) := \sin lx \sin ky,$$

or for Neumann boundary conditions

$$\phi_{kl}(x, y) := \cos kx \cos ly, \quad \phi_{lk}(x, y) := \cos lx \cos ky,$$

see [10]. The null space of the adjoint operator $\partial_u \Phi^*(0, 0, 0)$ is given by

$$(43) \quad \text{Ker}(\partial_u \Phi_0^*) = [\psi_1^*, \psi_2^*, \psi_3^*, \psi_4^*]$$

with $P_{21} = -B_0/\omega_0$ and

$$\psi_1^* := \frac{1}{P_{21}} (P^T e_2 \cos t + e_2 \sin t) \phi_{kl}, \quad \psi_2^* := \frac{1}{P_{21}} (-e_2 \cos t + P^T e_2 \sin t) \phi_{kl},$$

$$\psi_3^* := \frac{1}{P_{21}} (P^T e_2 \cos t + e_2 \sin t) \phi_{lk}, \quad \psi_4^* := \frac{1}{P_{21}} (-e_2 \cos t + P^T e_2 \sin t) \phi_{lk}.$$

This gives

$$(44) \quad \langle \psi_i^*, \psi_j \rangle = \delta_{ij}, \quad i, j = 1, \dots, 4$$

with the L^2 -product

$$(45) \quad \langle u, v \rangle = \frac{1}{2\pi} \int_0^{2\pi} \left(\frac{4}{\pi^2} \int_{\Omega} (u, v) dx dy \right) dt$$

in $\hat{C}_{2\pi}$, where (\cdot, \cdot) represents the Euclidean product in \mathbb{R}^2 . Since $\partial_u \Phi_0$ is a Fredholm operator with index 0 and its zero eigenvalues are of semisimple type, we have the decompositions

$$(46) \quad \hat{C}_{2\pi} = \text{Ker}(\partial_u \Phi_0) \oplus \text{Im}(\partial_u \Phi_0), \quad C_{2\pi}^1 = \text{Ker}(\partial_u \Phi_0) \oplus (\text{Im}(\partial_u \Phi_0) \cap C_{2\pi}^1).$$

Define the $\mathbf{D}_4 \times \mathbf{S}^1$ -equivariant projection $\hat{Q} : C_{2\pi} \rightarrow \text{Im}(\partial_u \Phi_0)$ by

$$(47) \quad \hat{Q}w := w - \sum_{i=1}^4 \langle \psi_i^*, w \rangle \psi_i, \quad w \in C_{2\pi}.$$

Equation (46) shows that \hat{Q} is a projection from $C_{2\pi}^1$ into $\text{Im}(\partial_u \Phi_0) \cap C_{2\pi}^1$. Moreover, $Q = \hat{Q}|_{C_{2\pi}^1}$.

3.2. Equivariance of the equations. The symmetries of the domain together with time-translation give the problem a $\mathbf{D}_4 \times \mathbf{S}^1$ equivariance. This will be utilized to reduce the computational work. The \mathbf{D}_4 action on $\Omega = [0, \pi] \times [0, \pi]$ is generated by action of the reflections R and S ,

$$(48) \quad R(x, y) = (y, x), \quad S(x, y) = (\pi - x, y) \quad \forall (x, y) \in \Omega.$$

The action of $\mathbf{D}_4 \times \mathbf{S}^1$ on $C_{2\pi}$ is given by

$$(\delta, \theta) \begin{pmatrix} u(x, y, t) \\ v(x, y, t) \end{pmatrix} = \begin{pmatrix} u(\delta^{-1}(x, y), t - \theta) \\ v(\delta^{-1}(x, y), t - \theta) \end{pmatrix} \quad \forall (\delta, \theta) \in \mathbf{D}_4 \times \mathbf{S}^1.$$

This action induces an action on \mathbb{R}^4 , coordinates in the null space $\sum \alpha_i \psi_i$. Since

$$\begin{aligned} S\phi_{kl} &= (-1)^k \phi_{kl}, & R\phi_{kl} &= \phi_{lk}, \\ S\phi_{lk} &= (-1)^l \phi_{lk}, & R\phi_{lk} &= \phi_{kl} \end{aligned}$$

hold for Neumann boundary conditions (and similarly for Dirichlet), the induced action of \mathbf{D}_4 on $(\alpha_1, \dots, \alpha_4)$ is generated by

$$S(\alpha_1, \alpha_2, \alpha_3, \alpha_4)^T = ((-1)^k \alpha_1, (-1)^k \alpha_2, (-1)^l \alpha_3, (-1)^l \alpha_4)^T$$

and

$$R(\alpha_1, \alpha_2, \alpha_3, \alpha_4)^T = (\alpha_3, \alpha_4, \alpha_1, \alpha_2)^T.$$

The action of \mathbf{S}^1 induced on $(\alpha_1, \dots, \alpha_4)$ is

$$T_\theta \begin{pmatrix} \alpha_1 \\ \alpha_2 \\ \alpha_3 \\ \alpha_4 \end{pmatrix} := \begin{pmatrix} \cos \theta & \sin \theta & 0 & 0 \\ -\sin \theta & \cos \theta & 0 & 0 \\ 0 & 0 & \cos \theta & \sin \theta \\ 0 & 0 & -\sin \theta & \cos \theta \end{pmatrix} \begin{pmatrix} \alpha_1 \\ \alpha_2 \\ \alpha_3 \\ \alpha_4 \end{pmatrix}.$$

In particular,

$$(49) \quad T_\pi \alpha = -\alpha, \quad T_{\pi/2} \alpha = (\alpha_2, -\alpha_1, \alpha_4, -\alpha_3)^T.$$

Hence, the symmetry group of the (reduced) bifurcation equation depends on the parity of (k, l) . We have the following possibilities (the genericity of which is discussed at length in Crawford [15]):

- Both k, l are even, implying

$$S\alpha = \alpha.$$

Together with (49) we see that $\mathbf{D}_4 \times \mathbf{S}^1$ acts reducibly on \mathbb{R}^4 .

- Both k, l are odd, implying

$$S\alpha = -\alpha.$$

Here we also have $\mathbf{D}_4 \times \mathbf{S}^1$ acting reducibly on \mathbb{R}^4 .

- $(k, l) = (\text{even}, \text{odd})$ (or $(k, l) = (\text{odd}, \text{even})$), implying

$$S\alpha = (\alpha_1, \alpha_2, -\alpha_3, -\alpha_4) \quad (\text{or } S\alpha = -(\alpha_1, \alpha_2, -\alpha_3, -\alpha_4)).$$

In this case $\mathbf{D}_4 \times \mathbf{S}^1$ acts irreducibly on \mathbb{R}^4 .

Note that the parity of the modes can also have an important effect on the nonlinear terms in the normal form for steady state bifurcation, in particular in mode interactions (cf. Gomes [24], Crawford [15]). We limit our discussion to the third case, where we can use generic $D_4 \times S^1$ bifurcation theory. Work is underway to apply this method to the other cases [8].

3.3. Results. The details of the calculations to produce B_3 , the cubic truncation of the reduced equations, are given in the Appendix. Recall from Swift [34] that the normal form for D_4 Hopf bifurcation is determined to cubic order by three complex coefficients U, V, W , and can be written

$$(50) \quad 0 = z_+[\mu + i\phi + U(|z_+|^2 + |z_-|^2) + V|z_+|^2] + W\bar{z}_+z_-^2$$

with the equation for z_- obtained by interchanging z_+ and z_- . The variables z_+, z_- and μ, ϕ represent state and control variables, all of which are zero at the bifurcation point. In this case the null space is parameterized by $(z_+, z_-) \in \mathbb{C}^2$, and the actions of the group are given by

$$R(z_+, z_-) = (-iz_-, iz_+), \quad S(z_+, z_-) = \pm(z_-, z_+), \\ T_\theta(z_+, z_-) = e^{i\theta}(z_+, z_-).$$

By defining

$$z_+ = \alpha_1 + \alpha_4 + i(\alpha_2 - \alpha_3), \\ z_- = \alpha_1 - \alpha_4 + i(\alpha_2 + \alpha_3)$$

and changing to these coordinates in \mathbb{C}^2 , we obtain the normal form (50) at cubic order. We remark that although the work of Swift involves analyzing a dynamical normal form (i.e., \dot{z}_+ replaces 0 on the left-hand side of (50)), all results regarding branching of periodic solutions carry over to our steady state case. In order to get dynamical information as well (for example, branching of quasiperiodic solutions), it is necessary to perform a center manifold reduction of the original equations.

For our case, it follows from equations (54) and (55) (in the Supplement section) that the parameters in (50) are given by

$$\mu := \lambda/2, \\ \phi := \tau + d_0c/2\lambda,$$

implying that (μ, ϕ) is uniquely determined by (λ, τ) . The nondegeneracy conditions for determinacy of directions of branching (i.e., not including their stability) are:

$$(51) \quad R_u := \operatorname{Re}(U + V/2 + W/2) \neq 0, \\ R_v := \operatorname{Re}(U + V/2 - W/2) \neq 0, \\ R_w := \operatorname{Re}(U + V) \neq 0, \\ |V|^2 \neq |W|^2 \neq |\operatorname{Re}(V\bar{W})|.$$

The real variables R_u, R_v and R_w determine the branching of the three solutions with the three isotropy subgroups with 2-dimensional fixed point spaces; the *Vertex, Edge* and *Rotating* waves referred to by Swift [34]. These are periodic solutions branching from the trivial solution with the maximal symmetry types indicated in Table 1. The symmetry of vertex (resp. edge) waves is the reflection R (resp. S). The symmetry of rotating waves relates to its name,

TABLE 1. The quantities R_u , R_v , R_w determine the branching of solutions with the three maximal isotropy types as the parameter $\mu = \lambda/2$ varies. The $\tilde{\mathbf{D}}_2$ correspond to symmetries generated by reflection in two planes coupled with a temporal phase shift of half a period for one of them.

i.e., the rotation generated by $R \cdot S$ combined with a temporal phase shift of one quarter of a period.

Of special interest in this system is the possible existence of branches of solutions with *submaximal* isotropy, i.e., branches not predicted by the equivariant Hopf branching lemma of Golubitsky and Stewart [22]. In this system, there can be such solutions with no symmetry bifurcating from the trivial solution if the following condition is fulfilled:

$$|V|^2 > |W|^2 > |\operatorname{Re}(V\overline{W})|.$$

We concentrate on computing the Hopf bifurcation of the $(1, 2) : (2, 1)$ spatial modes for the Brusselator equations with $A_0 = 1$, several values of d_0 and using two different (homogeneous) boundary conditions.

3.3.1. Neumann boundary conditions. In order to validate the method, we chose first to calculate the results for Neumann boundary conditions, and verify them against the analytical results obtained in [10]. All the computations are done with double precision in the finite difference methods and using a trapezoidal integration rule with adapted weights for the points on edges and corners. The values of U , V , and W in the reduced bifurcation equation (50) were obtained for various values of the discretization parameter at Hopf bifurcation with $A = 1$, $d_0 = 1/5$, and as can be seen in Table 2. Table 3 shows what these values of the coefficients imply for the various quantities determining the branching behavior. In this case, we can verify that the assumptions of 3-determinacy and stability are satisfied for small enough h ; the nondegeneracy conditions (51) are satisfied. There is excellent h^2 -convergence of the numerical predictions to the exact results. For example, if we denote the error of numerical approximations of R_u as a function $\operatorname{Err}(h, R_u)$, the first column of Table 3 shows $\operatorname{Err}(1/10, R_u) = 0.0202$, $\operatorname{Err}(1/20, R_u) = 0.004$, $\operatorname{Err}(1/40, R_u) = 0.00102$, which in turn indicates the h^2 -convergence. As can be seen from Table 3, for Neumann boundary condition Hopf bifurcation of the $(1, 2) : (2, 1)$ modes, all branches of solutions exist only for μ (and therefore λ) positive. We can also see that the conditions for existence of solutions with submaximal symmetry are satisfied.

The h refers to the step size for discretization, and the reduced equation is determined by the three complex coefficients U , V and W . 3.3.2. Dirichlet boundary conditions. The only part of the reduction that needs to be changed for the imposition of Dirichlet boundary conditions ($u_1 = u_2 = 0$ on $\partial\Omega$ after shifting) is in the solution of the linear problems detailed in the Appendix. Summarizing the results in Tables 4 and 5, we can say that the branches of rotating waves bifurcate in the direction $\lambda < 0$ while the other two are still bifurcating in the direction $\lambda > 0$. Note that in all the computations, the condition for existence of solutions with submaximal symmetry are not satisfied.

3.3.3. *Varying d_0 .* Table 6 shows an example of predicted real branching coefficients for $(1, 2) : (2, 1)$ mode Hopf bifurcations with Dirichlet boundary conditions, for a range of values of d_0 , with $A = 1$.

TABLE 6. By changing d_0 with $A = 1$, we display the predicted real quantities determining branching at Hopf bifurcation with Dirichlet boundary conditions. These are calculated by extrapolating the results for $h = 1/10, \dots, 1/40$ to $h = 0$. Note that there are higher codimension bifurcations occurring as we change d_0 ; for example, R_w changes sign near $d_0 = 0.17$ implying that the branch of rotating waves changes criticality nearby. When $R_w = 0$, the branching is determined by fifth-order terms.

4. COMPUTATION OF THE LIAPUNOV-SCHMIDT REDUCTION

We provide here the details of the computations performed to provide the reduced bifurcation equations for Brusselator Hopf bifurcation. We use splittings and null space projections as defined in § 3. For λ, τ in (37)-(39) and for any

$$(53) \quad \eta := (z, \lambda, \tau) = \left(\sum_{i=1}^4 \alpha_i \psi_i, \lambda, \tau \right) \in \text{Ker}(\partial_u \Phi_0) \times \mathbb{R}^2 = \text{Ker}(\Phi'_0),$$

we find that the truncated bifurcation equations to second order are given by

$$(54) \quad \begin{aligned} B_2(z, \lambda, \tau) &= (I - \hat{Q}) j_2 R \left(\sum_{i=1}^4 \alpha_i \psi_i, \lambda, \tau \right) \\ &= (I - \hat{Q}) \left\{ \begin{pmatrix} 1 & 0 \\ -1 & 0 \end{pmatrix} \lambda \sum_{i=1}^4 \alpha_i \psi_i + \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{A_0} \left(\sum_{i=1}^4 \alpha_i \psi_i^1 \right)^2 \right. \right. \\ &\quad \left. \left. + 2A_0 \left(\sum_{i=1}^4 \alpha_i \psi_i^1 \right) \left(\sum_{i=1}^4 \alpha_i \psi_i^2 \right) \right] - \tau \partial_i \sum_{i=1}^4 \alpha_i \psi_i \right\}, \end{aligned}$$

where we have used the notation $\psi_i = (\psi_i^1, \psi_i^2)^T$ and j_2 truncates to the polynomial of degree 2 in the Taylor expansion of Φ at $(0, 0, 0)$ with respect to α_i, λ and τ . In view of the orthogonality properties of $\{\phi_{ki}\}$, we can write

$$\begin{aligned} B_2(z, \lambda, \tau) &= (I - \hat{Q}) \left[\begin{pmatrix} 1 & 0 \\ -1 & 0 \end{pmatrix} \lambda \sum_{i=1}^4 \alpha_i \psi_i - \tau \partial_i \sum_{i=1}^4 \alpha_i \psi_i \right] \\ &= \sum_{j=1}^4 \left\langle \psi_j^*, \begin{pmatrix} 1 \\ -1 \end{pmatrix} \lambda \sum_{i=1}^4 \alpha_i \psi_i^1 - \tau \partial_i \left(\sum_{i=1}^4 \alpha_i \psi_i \right) \right\rangle \psi_j \\ &= \frac{1}{2} \{ [(\alpha_1 - \alpha_2(P_{11} - P_{12}))\lambda - 2\tau\alpha_2] \psi_1 + [((P_{11} - P_{12})\alpha_1 + \alpha_2)\lambda + 2\tau\alpha_1] \psi_2 \\ &\quad + [(\alpha_3 - \alpha_4(P_{11} - P_{12}))\lambda - 2\tau\alpha_4] \psi_3 + [((P_{11} - P_{12})\alpha_3 + \alpha_4)\lambda + 2\tau\alpha_3] \psi_4 \} \\ &= 0, \end{aligned}$$

these, we study the right-hand sides of the equations (58):

$$\begin{aligned}
 (59) \quad f_0(\alpha, \lambda, \tau) &= \begin{pmatrix} -1 \\ 1 \end{pmatrix} \sum_{i,j=1}^4 \alpha_i \alpha_j \left[\frac{B_0}{2A_0} (\mu_i \mu_j + \xi_i \xi_j) + A_0 (\mu_i \nu_j + \xi_i \eta_j) \right], \\
 (60) \quad f_1(\alpha, \lambda, \tau) &= -\hat{Q} \sum_{i=1}^4 \alpha_i \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\mu_i \lambda - \tau \begin{pmatrix} \xi_i \\ \eta_i \end{pmatrix} \right], \\
 (61) \quad f_2(\alpha, \lambda, \tau) &= -\hat{Q} \sum_{i=1}^4 \alpha_i \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\xi_i \lambda + \tau \begin{pmatrix} \mu_i \\ \nu_i \end{pmatrix} \right], \\
 (62) \quad f_3(\alpha, \lambda, \tau) &= \begin{pmatrix} -1 \\ 1 \end{pmatrix} \sum_{i,j=1}^4 \alpha_i \alpha_j \left[-\frac{B_0}{2A_0} (\mu_i \mu_j - \xi_i \xi_j) + A_0 (\mu_i \nu_j - \xi_i \eta_j) \right], \\
 (63) \quad f_4(\alpha, \lambda, \tau) &= \begin{pmatrix} -1 \\ 1 \end{pmatrix} \sum_{i,j=1}^4 \alpha_i \alpha_j \left[\frac{B_0}{A_0} \mu_i \xi_j + A_0 (\mu_i \eta_j + \xi_i \nu_j) \right],
 \end{aligned}$$

where we have used the notation

$$\psi_i = \begin{pmatrix} \mu_i \\ \nu_i \end{pmatrix} \cos t + \begin{pmatrix} \xi_i \\ \eta_i \end{pmatrix} \sin t, \quad i = 1, \dots, 4.$$

For the given basis of $\text{Ker}(\partial_u \Phi_0)$ in (43), elementary calculations yield

$$(64) \quad f_0(\alpha, \lambda, \tau) = -\begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{2A_0} (1 + P_{11}^2) + A_0 P_{11} P_{21} \right] (\alpha_1^2 \phi_k^2 + 2\alpha_1 \alpha_3 \phi_k \phi_k + \dots),$$

while the coefficients of the terms $\alpha_1 \alpha_2, \alpha_1 \alpha_4$ are equal to zero. Similarly,

$$(65) \quad \begin{pmatrix} f_1(\alpha, \lambda, \tau) \\ f_3(\alpha, \lambda, \tau) \end{pmatrix} = -\hat{Q} \begin{pmatrix} \lambda - \tau P_{11} & -\lambda P_{11} - \tau \\ -\lambda - \tau P_{11} & \lambda P_{11} \\ \lambda P_{11} + \tau & \lambda - \tau P_{11} \\ -\lambda P_{11} & -\lambda - \tau P_{21} \end{pmatrix} \begin{pmatrix} \alpha_1 \phi_k + \alpha_3 \phi_k \\ \alpha_2 \phi_k + \alpha_4 \phi_k \end{pmatrix}$$

and

$$\begin{aligned}
 (66) \quad f_3(\alpha, \lambda, \tau) &= -\begin{pmatrix} -1 \\ 1 \end{pmatrix} \left\{ \frac{B_0}{2A_0} (1 - P_{11}^2) - A_0 P_{11} P_{21} \right\} (\alpha_1^2 \phi_k^2 + 2\alpha_1 \alpha_3 \phi_k \phi_k) \\
 &\quad - 2 \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) (\alpha_1 \alpha_2 \phi_k^2 + \alpha_1 \alpha_4 \phi_k \phi_k) + \dots, \\
 f_4(\alpha, \lambda, \tau) &= -\begin{pmatrix} -1 \\ 1 \end{pmatrix} \left[\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right] (\alpha_1^2 \phi_k^2 + \alpha_1 \alpha_3 \phi_k \phi_k) \\
 &\quad + \left(\frac{B_0}{A_0} (1 - P_{11}^2) - 2A_0 P_{21} P_{11} \right) (\alpha_1 \alpha_2 \phi_k^2 + \alpha_1 \alpha_4 \phi_k \phi_k) + \dots.
 \end{aligned}$$

Since f_i are polynomials of $\alpha \in \mathbb{R}^4$ and $\lambda, \tau \in \mathbb{R}$, in particular, f_0, f_3, f_4 are independent of λ, τ , the functions $w_2^i, i = 0, \dots, 4$, are also polynomials of α, λ, τ

which gives

$$(55) \quad \frac{1}{2} \begin{pmatrix} \lambda & \alpha_3 \\ (P_{11} - P_{12})\lambda + 2\tau & \alpha_4 \end{pmatrix} \begin{pmatrix} \alpha_1 & \alpha_3 \\ \alpha_2 & \alpha_4 \end{pmatrix} = 0.$$

Evidently, $B_2(z, \lambda, \tau)$ is not determined as it has vertically branching bifurcating solutions; we have a linear equation for α_i that has only zero as a solution unless λ, τ are both zero. To investigate the structure of solution branches of (37) at $(0, 0, 0)$, the next step of the truncated Liapunov-Schmidt method is needed.

4.1. Calculating w_2 . To find the third-order truncation, we first need to solve w_2 from the equation

$$\begin{aligned}
 \partial_u \Phi(0, 0, 0) w_2 &= -\hat{Q} j_2 R \left(\sum_{i=1}^4 \alpha_i \psi_i, \lambda, \tau \right) \\
 &= -\hat{Q} \left\{ \begin{pmatrix} 1 & 0 \\ -1 & 0 \end{pmatrix} \lambda \sum_{i=1}^4 \alpha_i \psi_i + \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{A_0} \left(\sum_{i=1}^4 \alpha_i \psi_i^2 \right)^2 \right. \right. \\
 &\quad \left. \left. + 2A_0 \left(\sum_{i=1}^4 \alpha_i \psi_i^3 \right) \left(\sum_{i=1}^4 \alpha_i \psi_i^2 \right) \right] - \tau \partial_t \sum_{i=1}^4 \alpha_i \psi_i \right\} \\
 &=: f(\alpha, \lambda, \tau).
 \end{aligned}$$

Note that the right-hand side is a periodic function in t . More precisely, we have

$$(56) \quad f(\alpha, \lambda, \tau) = f_0 + f_1 \cos t + f_2 \sin t + f_3 \cos 2t + f_4 \sin 2t,$$

where $f_i, i = 0, 1, \dots, 4$, are functions of α, λ, τ and z, y only. Decomposing the expected solution in the form

$$(57) \quad w_2 = w_2^0 + w_2^1 \cos t + w_2^2 \sin t + w_2^3 \cos 2t + w_2^4 \sin 2t,$$

we solve the coefficients from the equations

$$(58a) \quad L(B_0) w_2^0 = f_0(\alpha, \lambda, \tau),$$

$$(58b) \quad \begin{pmatrix} L(B_0) & -\omega_0 I \\ \omega_0 I & L(B_0) \end{pmatrix} \begin{pmatrix} w_2^1 \\ w_2^2 \end{pmatrix} = \begin{pmatrix} f_1(\alpha, \lambda, \tau) \\ f_2(\alpha, \lambda, \tau) \end{pmatrix},$$

$$(58c) \quad \begin{pmatrix} L(B_0) & -2\omega_0 I \\ 2\omega_0 I & L(B_0) \end{pmatrix} \begin{pmatrix} w_2^3 \\ w_2^4 \end{pmatrix} = \begin{pmatrix} f_3(\alpha, \lambda, \tau) \\ f_4(\alpha, \lambda, \tau) \end{pmatrix}.$$

Determining the expressions f_0, \dots, f_4 in terms of the parameters of the problem and the null space coordinates, and then selecting the coefficients of the various monomials in the α_i gives us a set of linear problems on the square. To obtain

of the same form as f_i . Their coefficients can be solved from the corresponding equations. For example, the equation for the coefficient independent of t will be

$$(67) \quad L(B_0)w_2^{ij} = - \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{2A_0}(\mu_i\mu_j + \xi_i\eta_j) + A_0(\mu_i\nu_j + \xi_i\eta_j) \right]$$

for $i, j = 1, \dots, 4$, and one gets the solution w_2^0 of (58) as

$$w_2^0 = \sum_{i,j=1}^4 \alpha_i \alpha_j w_2^{ij}.$$

In fact, (58b) can be solved analytically in the following way. The restriction of the operator

$$\begin{pmatrix} L(B_0) & -\omega_0 I \\ \omega_0 I & L(B_0) \end{pmatrix}$$

to the subspace $\text{span}\left\{ \begin{pmatrix} \phi_{1k}^* \\ 0 \end{pmatrix}, \begin{pmatrix} 0 \\ \phi_{1k}^* \end{pmatrix} \right\}$, $\begin{pmatrix} \phi_{2k}^* \\ 0 \end{pmatrix}, \begin{pmatrix} 0 \\ \phi_{2k}^* \end{pmatrix}$ reduces to the matrix

$$\omega_0 \begin{pmatrix} P & -I \\ I & P \end{pmatrix}.$$

Its inverse can be given explicitly (cf. (1)):

$$\omega_0 \dot{Q} \begin{pmatrix} P & -I \\ I & P \end{pmatrix}^{-1} \dot{Q} = -\frac{1}{4\omega_0} \begin{pmatrix} P & -I \\ I & P \end{pmatrix}.$$

Hence, the solution of (58b) is given by

$$(68) \quad \begin{pmatrix} w_2^0 \\ w_2^0 \end{pmatrix} = \frac{1}{4\omega_0} \begin{pmatrix} P & -I \\ I & P \end{pmatrix} \begin{pmatrix} \lambda - \tau P_{11} & -\lambda P_{11} - \tau \\ -\lambda - \tau P_{21} & \lambda P_{11} \\ \lambda P_{11} + \tau & \lambda - \tau P_{11} \\ -\lambda P_{11} & -\lambda - \tau P_{21} \end{pmatrix} \begin{pmatrix} \alpha_1 \phi_{1k} + \alpha_3 \phi_{1k} \\ \alpha_2 \phi_{1k} + \alpha_4 \phi_{1k} \end{pmatrix}.$$

Similarly, owing to the special form of f_0 in (64), the solution of (58a) can be generated by the solutions of the following two equations:

$$(69a) \quad L(B_0)u = - \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{2A_0}(1 + P_{11}^2) + A_0 P_{11} P_{21} \right] \phi_{1k}^2,$$

$$(69b) \quad L(B_0)u = - \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{2A_0}(1 + P_{11}^2) + A_0 P_{11} P_{21} \right] \phi_{1k} \phi_{1k}.$$

Concerning the equation (58c), together with (66), one sees that its solution can

be generated from the solutions of the following four equations:

$$(70) \quad \mathcal{L} \begin{pmatrix} u_1 \\ v_2 \end{pmatrix} = \begin{pmatrix} \frac{B_0}{2A_0}(1 - P_{11}^2) - A_0 P_{11} P_{21} \\ \frac{B_0}{A_0} P_{11} + A_0 P_{21} \end{pmatrix} \phi_{1k}^2,$$

$$(71) \quad \mathcal{L} \begin{pmatrix} u_1 \\ v_2 \end{pmatrix} = \begin{pmatrix} -2 \binom{-1}{1} \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) \phi_{1k}^2 \\ \frac{B_0}{A_0}(1 - P_{11}^2) - 2A_0 P_{21} P_{11} \end{pmatrix} \phi_{1k}^2,$$

$$(72) \quad \mathcal{L} \begin{pmatrix} u_1 \\ v_2 \end{pmatrix} = \begin{pmatrix} 2 \binom{-1}{1} \frac{B_0}{A_0} (1 - P_{11}^2) - A_0 P_{11} P_{21} \\ 2 \binom{-1}{1} \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) \phi_{1k} \phi_{1k} \end{pmatrix},$$

$$(73) \quad \mathcal{L} \begin{pmatrix} u_1 \\ v_2 \end{pmatrix} = \begin{pmatrix} -2 \binom{-1}{1} \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) \phi_{1k} \phi_{1k} \\ \frac{B_0}{A_0}(1 - P_{11}^2) - 2A_0 P_{21} P_{11} \end{pmatrix} \phi_{1k} \phi_{1k},$$

where

$$\mathcal{L} := \begin{pmatrix} L(B_0) & -2\omega_0 \\ 2\omega_0 & L(B_0) \end{pmatrix}.$$

As an example, we consider solution of (70). Observing its right-hand side, one sees

$$\begin{pmatrix} -1 \\ 1 \end{pmatrix} \left[\frac{B_0}{2A_0}(1 - P_{11}^2) - A_0 P_{11} P_{21} \right] \phi_{1k}^2 \\ = \begin{pmatrix} -1 \\ 1 \end{pmatrix} \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) \phi_{1k}^2 \\ = \begin{pmatrix} 1 \\ 0 \\ 0 \end{pmatrix} \left[\frac{B_0}{2A_0}(1 - P_{11}^2) - A_0 P_{11} P_{21} \right] \phi_{1k}^2 + \begin{pmatrix} 0 \\ 0 \\ -1 \end{pmatrix} \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) \phi_{1k}^2.$$

Thus, solving the systems

$$(74) \quad \begin{pmatrix} L(B_0) & -2\omega_0 \\ 2\omega_0 & L(B_0) \end{pmatrix} \begin{pmatrix} v_1 \\ v_2 \end{pmatrix} = \begin{pmatrix} -1 \\ 1 \\ 0 \end{pmatrix} \phi_{1k}^2,$$

$$(75) \quad \begin{pmatrix} L(B_0) & -2\omega_0 \\ 2\omega_0 & L(B_0) \end{pmatrix} \begin{pmatrix} w_1 \\ w_2 \end{pmatrix} = \begin{pmatrix} 0 \\ 0 \\ 1 \end{pmatrix} \phi_{1k}^2,$$

we obtain the solution $(u_1, v_2)^T$ of (70) as follows:

$$\begin{pmatrix} u_1 \\ v_2 \end{pmatrix} = \left[\frac{B_0}{2A_0}(1 - P_{11}^2) - A_0 P_{11} P_{21} \right] \begin{pmatrix} v_1 \\ v_2 \end{pmatrix} + \left(\frac{B_0}{A_0} P_{11} + A_0 P_{21} \right) \begin{pmatrix} w_1 \\ w_2 \end{pmatrix}.$$

Moreover, we have

$$\begin{pmatrix} w_1 \\ w_2 \end{pmatrix} = \begin{pmatrix} -v_2 \\ v_1 \end{pmatrix}.$$

Consequently, we need only solve (74) in order to get the solutions of (70) and (71), respectively. Correspondingly, replacing the factors ϕ_{1k}^2 in (74) by $\phi_{1k} \phi_{1k}$, and solving it, one gets solutions of (72) and (73) similarly as above. Thus, we

can calculate all the coefficients w_2^{ij} for $k = 0, \dots, 4$ and $i, j = 1, \dots, 4$ from the solutions of the problems (69), (69b) and (74).

These problems are discretized using finite differences and then solved directly using the bandedness of the matrices in the discrete problems to give the coefficients for the various quadratic terms. Thus we can find the solutions w_2^k of (58a), (58c) in the form

$$(76) \quad w_2^k = \sum_{i,j=1}^4 \alpha_i \alpha_j w_2^{kij}, \quad k = 0, 3, 4.$$

The equivariance of the equations in (58) leads to the relations

$$\gamma w_2^i(\alpha) = w_2^j(\gamma\alpha) \quad \forall \gamma \in D_4 \times S^1, \quad i = 0, 3, 4.$$

Thus, once the coefficients $w_2^{11}, w_2^{12}, w_2^{13}, w_2^{14}$ of the terms $\alpha_1^2, \alpha_1\alpha_2, \alpha_1\alpha_3, \alpha_1\alpha_4$ in the expansion of $w_2^1, i = 0, 3, 4$, are known, all other terms can be derived via group actions. Hence to solve the equations (58), we solve four equations corresponding to $(i, j) = (1, 1), (1, 2), (1, 3), (1, 4)$ in the expansion of the right-hand side of (58) with respect to $\alpha_1, \dots, \alpha_4$. Even in the computation of these coefficients, the special structure of the systems allows further decomposition of the solutions and reduction of computational effort. In fact, the right-hand sides of (58) consist of products of various eigenfunctions of the Laplacian on the square and possess rich nodal line properties; in view of the underlying periodic boundary conditions of these linear systems, we can often restrict the problem to smaller fundamental domains; see e.g., Mei [2].

4.2. Calculating B_3 . Once again, we can use the symmetries of the problem to considerably reduce the number of calculations required for the bifurcation equations truncated to third order.

Note that we know all the second-order terms from the calculation of B_2 , and so we only need to consider the third-order terms from the right-hand side of the equivalent to equation (11). This was performed by a Maple code, which generated the pointwise values of the function (in terms of the w_2) that, when integrated, gave the coefficients of B_3 . The Maple expression was then transcribed into (10k byte of) optimized Fortran formula. For simplicity, we briefly give the main idea used to calculate B_3 . For $u = (u_1, u_2)^T, v = (v_1, v_2)^T \in C_{2\pi}^1$, we define

$$R_1(u, v) := \begin{pmatrix} 1 \\ -1 \end{pmatrix} \left[\frac{B_0}{A_0} u_1 v_1 + 2A_0 \frac{u_1 v_2 + u_2 v_1}{2} \right], \quad R_2(u) := \begin{pmatrix} 1 \\ -1 \end{pmatrix} u_1,$$

$$R_3(u, u, u) := \begin{pmatrix} 1 \\ -1 \end{pmatrix} u_1^2 v_2, \quad R_4(u, v) := \begin{pmatrix} 1 \\ -1 \end{pmatrix} u_1 v_1 / A_0.$$

Hence, for

$$\eta := (z, \lambda, \tau) = \left(\sum_{i=1}^4 \alpha_i \psi_i, \lambda, \tau \right) \in \text{Ker}(\partial_u \Phi_0) \times \mathbb{R}^2,$$

we have

$$(77) \quad \begin{aligned} B_3(z, \lambda, \tau) &= (I - Q) j_3 R \left(\sum_{i=1}^4 \alpha_i \psi_i + w_2, \lambda, \tau \right) \\ &= B_2(z, \lambda, \tau) + (I - Q) (2R_1(z, w_2(\eta)) + \lambda R_2(w_2(\eta)) \\ &\quad + R_3(z, z, z) + \lambda R_4(z, z) - \tau \delta_1 w_2(\eta)). \end{aligned}$$

Again, B_3 is $D_4 \times S^1$ equivariant. Once $w_2(\eta)$ is known, $B_3(\eta)$ follows from simple calculations consisting mainly of L^2 -products in $C_{2\pi}$.
