Guidelines for Authors

Open Access and Copyright Policy

All content in the Journal is published Open Access under the <u>Creative Commons Attribution</u> (<u>CC BY 4.0</u>) <u>license</u>. Authors retain copyright on their published articles. All authors of the article agree to and accept the conditions of the <u>License Agreement</u> to be signed during submission by the Corresponding Author on behalf and with the consent of all authors of the article.

Plagiarism and Author Ethics

The journal's policy towards plagiarism, multiple publications, authorship, etc. is detailed in Policy and Ethics section. Every paper submitted to the Journal shall be checked by the <u>iThenticate</u> tool for similarity and plagiarism detection.

Submission process

The manuscripts shall be submitted electronically via the online platform on the Academic OA website. The submitted manuscripts shall meet the following requirements:

- conformity with the journal's scope and general requirements including those provided by the COPE;
- first publication: the manuscript shall not be published or presented previously in any source either in print or digital form. Exceptions include presentation of an abstract or in the form of the published lecture, academic thesis or electronic preprint;
- novelty: the manuscript presented by the author should be an original research work or objective and unbiased review paper prepared by the author/authors based on their own study and findings;
- transparency and responsibility: all sources used for preparation of the manuscript shall be properly cited; the agreement of all co-authors shall be clearly received by the corresponding author; all contributors shall be accordingly nominated for the authorship;
- technical soundness: the manuscript should be structure in accordance with the journal's template and the below submission instructions.

Submission instructions

Before starting your work in the Author account, please go through the Author Manual describing the submission process step by step.

- 1. **Registration.** Register on the Academic OA, log in and proceed with submission from the personal account in accordance with instructions.
- 2. **Template.** To prepare the manuscript, please use the MS Word Doc or LaTeX templates. Main technical rules are summarized in the template. The manuscript shall be uploaded both in

Doc/LaTeX and Pdf formats. LaTeX manuscripts shall be zip archived and contain all source files/images.

3. **Language.** The language of the manuscript shall be English. All text elements including in tables, figures, graphs, etc. shall be also in English. Quality of language and presentation shall be of high level, structure – logical and content – consistent.

Paper Title. After preparing the paper, write a title for it. It should reflect the main idea and the content of the paper in an adequate manner. It should be simple, clear, specific and avoid abbreviations.

Authors and affiliations. All authors having substantially contributed to the paper, should be accordingly mentioned in it. Please provide their full names and check the spelling carefully. Their affiliations shall be indicated in the following order: Department, Institution, Institution address (City, Country). In addition, please provide the email addresses of all authors. The name of the Corresponding Author shall be marked with an asterisk.

Keywords. Please prepare a list of keywords that identify your paper. Keywords are essential for making your paper visible in search engines and will be used for a keyword index.

Abstract. The abstract is a brief summary of the paper that shall reflect the general purpose of the research or review, describe the basic methodology, outline the main results of the research / experiment and provide conclusions. The abstract should be concise and shall not exceed 150-300 words. It shall be written as a single paragraph. Please do not provide references in the abstract.

When you mention some classification schemes (PACS, MSC2010, etc.), please provide their codes after the abstract. Such codes will be of help for assigning proper referees.

Introduction. The Introduction shall outline the rationale of the research, present the problem and the proposed solution as well as its relevance for readers, and review the literature pertaining to the research, giving an idea of the article although avoiding the detailed descriptions.

Theory. In the Theory section please provide the theoretical background and overview of the applied methodology that allowed to conduct an experiment or research and get the actual results.

Methods and Materials. The Materials and Methods section shall provide structure and the flow of the experiment or research, describing the procedure in detail sufficient for the reader to reproduce the experiment and get the stated results. The authors shall focus on: utilized materials and nuances of their preparation, research methods, measurement and evaluation technics, statistical tests, applied software for analysis, and etc.

Results. This section shall report and interpret the findings of the experiment or research. The results shall be presented in a distinct and concise manner and shall be proven and justified.

Discussion. In this section the relevance and importance of the research findings are given. The authors shall interpret the results, describe implications and limitations as well as provide recommendations for further study or practical use.

Conclusions. It is the final part of the research summarizing the results and demonstrating the importance of the work.

Conflict of Interests. If there is an apparent or potential conflict of interests that may influence the interpretation or representation of the research findings, the authors are obliged to disclose all such circumstances in a clear manner. Otherwise, the Corresponding Author shall declare that to the best of the authors knowledge, there is no conflict of interest.

Here the authors shall disclose the influence and role of sponsors in the paper, its preparation, collection of data, interpretation of the results and etc.

Acknowledgements. It should be a single paragraph dedicated to appreciation of the persons / institutions directly involved in the preparation of the study / research. The authors shall properly disclose all funding sources of their paper, including grants, sponsorship in covering the publishing costs, and may mention non-funding support from their colleagues, supervisors, reviewers and other non-authors.

References. Referencing of the paper sources shall be arranged in the same numerical order as they appear in the paper text. Every source shall be listed once. The authors shall avoid irrelevant self-citations and shall properly mention every source according to the below patterns.

Reference Styles

Every **reference** shall present the information sufficient for identifying and search of the source. The reference shall contain the information about its authors, publication date, source title and page numbers, as well as other identifiers like DOI.

The full list of references shall appear at the end of the paper, while in the text it is presented as numbers in square brackets: [1], [1,5,9], [2-4].

If the source is authored by one to three authors, in the reference the names of all authors shall be mentioned. If there are more than three authors, only the name of the first author should be mentioned followed by "et al."

Other Text Elements

Tables

Tables style shall be simple, clear and easy for reading. Tables should not be broken into parts. Every table shall have its heading and number. In the text the tables are referred to as Table 1, Table 2, etc. Text shall be centered.

Figures

All figures shall be easy to read and be of good quality. For pictures, the minimum resolution is 300 dpi (dots per inch). Every figure shall have caption and number. In the text the figures are referred to as Fig. 1, Fig. 2, etc. Every figure shall appear closer to the point where it was first mentioned.

Equations and mathematics

Every equation shall be easy to read and appear as editable elements (formulas) instead of pictures. Equations shall be numbered in the numerical order. In the text the equations are referred to as Eq.(1).

Scientific names

All scientific names shall appear in full form when they appear in the text for the first time and shall be abbreviated thereinafter. The names of the genus and species shall be given in italics.

Qualification for Authorship

Authorship credit in the paper shall be based on the persons' contribution to this paper by way of (including but not limited to): (i) development of the paper concept, design or structure; (ii) processing or calculating data; (iii) drafting, analysing or revising of the work and work results; (iv) accountability for the work, its results and integrity, and etc. Persons that are not qualified for authorship may be mentioned in the Acknowledgement section.

Quality Control

As soon as the manuscript is submitted, the Editors do a preliminary evaluation of the paper to identify its relevance to the journal's scope and its conformity with the basic journal requirements. Depending on the outcome, the Editors either decline the paper or assign reviewers. That is followed by the peer-review process. Having reviewed the manuscript, the reviewers provide their recommendations and comments or full review reports to the Editors who have to check the submitted reports. Based on reviewers' recommendations and reports, the Editor decides whether to accept or reject the manuscript.

All Editors are obliged to follow the COPE's <u>Code of Conduct and Best Practice Guidelines for</u> Journal Editors.

All reviewers are obliged to follow the COPE's <u>Ethical Guidelines for Peer Reviewers.</u> For more details about the editorial process cycle please refer to the Peer Review & Quality Control.

Appeals

If the Authors do not agree with the Editors' decision, they can appeal to the Managing Editor at editors@academicoa.com with the relevant letter. The letter should outline the nature of appeal and reasons for filing it. The deadline for filing an appeal is the 10th business day after receipt of the Editors' decision which is thus appealed. The Managing Editor accordingly applies to the Editors with the received appeal, the latter are responsible for review and re-evaluation of the paper. The decision after re-evaluation shall be final and is not subject to further appeals.

Corrections and Additions after Publication

If some significant mistakes have been identified in the published article which resulted from the author's genuine error, the Editors may consider issuance of a Corrigendum thereto.

If there is a necessity to make an addition of significant information to the published article, the Editors may consider issuance of an Addendum thereto. Such an Addendum can be published only if the additions to the paper are critical, improve it or are necessary for understanding or interpreting the content.

All Addenda and Corrigenda shall be filed by the Corresponding Authors and accompanied by an official letter signed by all authors of the paper approving such corrections. After approval by the Editors, Addenda shall be published in the next journal's volume.
