

## **HYDROMX INC LIMITED WARRANTY**

Hydromx Inc (“Hydromx”) warrants that the Hydromx Products, whether sold directly or through a reseller or distributor, when installed in accordance with Hydromx Guidelines, and when utilized in normal and contemplated uses in accordance with Hydromx’s Guidelines, will be free of defects and fit for the purpose intended for a period of 20 years from the date of manufacture. This limited warranty is in lieu of all other warranties of local law or otherwise, and neither Hydromx nor any affiliate of Hydromx makes any implied warranty of merchantability of any sort. Customer’s sole remedy for a breach of this limited warranty or for any liability which cannot be excluded as provided in any applicable law, shall be a refund of the amount actually paid by the Customer for the defective Product.

This Limited Warranty does not cover any loss caused by accidents or careless handling of a Hydromx Product. This Limited Warranty does not apply to any Hydromx Product that has been abused, altered, modified, or used in a manner not originally intended or not in accordance with Hydromx Guidelines. This Limited Warranty does not cover any Product that has been installed in a manner that is not consistent with Product Installation Guidelines.

THE LIMITED WARRANTY SET FORTH ABOVE IS THE ONLY WARRANTY HYDROMX MAKES FOR ITS PRODUCTS AND IS IN LIEU OF ALL WARRANTIES EXPRESS, IMPLIED OR STATUTORY, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND INFRINGEMENT, AND WARRANTIES ARISING FROM COURSE OF DEALING, USAGE OF TRADE OR OTHERWISE. THE REMEDIES SET FORTH IN THIS LIMITED WARRANTY ARE THE ONLY REMEDIES AVAILABLE TO ANY PERSON CLAIMING FOR BREACH OF WARRANTY OR FOR ANY DAMAGES OF ANY KIND OR NATURE. HYDROMX SHALL NOT HAVE ANY OTHER LIABILITY OF ANY DESCRIPTION, WHETHER ARISING OUT OF WARRANTY (INCLUDING ANY IMPLIED WARRANTIES) OR ANY OTHER CONTRACT, NEGLIGENCE, TORT OR OTHERWISE, INCLUDING, BUT NOT LIMITED TO, COST FOR REMOVAL OF DEFECTIVE PRODUCT, COST FOR INSTALLATION OF ANY REPLACEMENT PRODUCT, COMMERCIAL LOSS FROM ANY CAUSE, BUSINESS INTERRUPTION OF ANY NATURE, LOSS OF PROFITS OR ANY OTHER CONSEQUENTIAL LOSS OR DAMAGE, EVEN IF HYDROMX HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE.

In the event any implied warranties (including, but not limited to the implied warranties of merchantability or fitness for a particular purpose) are found to exist, such warranties are limited (i) in duration to the period of the limited warranties set forth in this Limited Warranty, and (ii) in amount to the total amount paid to Hydromx for the product in question.
