In supersession of this office OM No. 5-2/2021-TC/TEC dated 13.04.2022, Director (IMP & TEP), TEC has been designated as the Appeal Officer under Mandatory Testing & Certification of Telecommunication Equipment (MTCTE).

2. with reference to the section 'IV' of MTCTE procedure, appeal against the decision taken by TEC w.r.t. their certification application under MTCTE may be sent to the Appeal Officer, in writing or on email to santosh.ksingh@gov.in within 30 days from the date of decision taken by TEC.

3. The Appeal shall be admitted if Appeal Officer satisfies that the appeal case prima-facie appears to be appropriate on ground stated by the appellant. The Applicant will be informed accordingly.

4. Admitted appeals shall be placed before the designated Appeals Committee and the Appeals Committee shall make the final decision within a reasonable time. The Appellant shall be informed of the same by Appeal Officer.


