It is hereby represented, and be it known, that THEA has retained an independent registered municipal advisor. THEA is represented by and will rely on its municipal advisor, PFM Financial Advisors LLC (PFMFA), to provide advice on recommendations or proposals from financial services firms concerning the issuance of municipal securities. This representation specifically excludes and may not be relied upon by market participants for purposes of the independent registered municipal advisor exemption under the Municipal Advisor Rule with respect to, recommendations or proposals concerning any investment strategy or any municipal financial product other than municipal derivatives. This representation may be relied upon until August 31, 2024, unless otherwise notified. Any recommendation or proposal concerning municipal derivatives, or the issuance of municipal securities may be addressed to THEA at 1104 East Twiggs Street, Tampa, FL 33602, Attention: Director of Finance. If the recommendation or proposal received is to be given significant consideration by the responsible officers at THEA, the document will be shared with PFMFA for review and advice. Please note that aside from regulatory mandated correspondence between an underwriter and municipal advisor, the underwriter is not required to speak directly with or to send documents directly to PFM unless specifically directed to by THEA.
