SUBJECT: Exception to Army Regulation 140-10, Army Reserve Assignment,
Attachments, Details, and Transfers

1. Reference, Army Regulation (AR) 140-10, Assignment, Attachments, Details, and Transfers
2. In accordance to AR 140-10, paragraph 3-2b, Area Commanders are the approval authority to authorized officer branch transfers and warrant officer military occupational specialty reclassifications. As an exception, this authority may be delegated to major subordinate commanders (MSC) with General Officer commanders or promotable COLs in GO positions. Delegation of authority below MSC level is not authorized.
3. This exception to policy is effective immediately and expires one year from the date of this memorandum unless superseded or rescinded.

SUBJECT: Exception to Policy and Change to Army Regulation 140-10

1. References.

a. Army Regulation (AR) 140-10, Assignments, Attachments, Details, and Transfers, 25 Apr 18.

b. Department of the Army Pamphlet (DA PAM) 600-3, Commissioned Officer Professional Development and Career Management, 3 Apr 19.

c. DA PAM 611-21, Military Occupational Classification and Structure, 19 Jul 18.

2. Request exception to AR 140-10, paragraph 3-2b, to allow Commander, U.S. Army Reserve Command (USARC) to delegate approval authority for officer branch transfer and area of concentration/functional area/military occupational specialty reclassification to the USARC Major Subordinate Commands (MSC) with general officer commanders with legal support. The 2018 update to AR 140-10 changed the delegation authority from MSCs to Regional Support Commands. Approval authority above the MSC-level degrades the Army Reserve's ability to efficiently and effectively support command formations.

3. Further request HQDA incorporates this change into the next revision of AR 140-10. DA Form 2028 enclosed.
